SYRIAN FORUM USA

Established in 2015 and operates through its offices in Chicago, Dallas, and Washington, D.C. Syrian Forum USA works in partnership with the Syrian Forum to support programs related to development & humanitarian affairs, economic empowerment, research & public policy, and advocacy to shed light on the humanitarian situation and the Syrian crisis.

Strategic Outreach and Engagement in 2024:

- Organized **10** major grassroots outreach tours across the United States, led by the Board of Directors. These tours aimed to share critical updates from the ground on the Syrian humanitarian crisis, foster a deeper understanding of the ongoing challenges, and encourage donor engagement. Throughout these tours, we held over 70 meetings and community events with existing and prospective partners and donors to promote informed dialogue and support for sustainable solutions in Syria.
- Hosted **124** fundraising and donor appreciation events, which not only helped secure crucial resources but also celebrated the unwavering generosity and commitment of our supporters. These events played a crucial role in sustaining our programs and expanding our impact.
- To amplify awareness of the Syrian cause on a national scale and enhance visibility for the ongoing needs of the Syrian people, the Syrian Forum USA participated in, and sponsored, 70 conferences and major events. These included high-profile gatherings organized by the Syrian American Medical Society (SAMS), Islamic Circle of North America (ICNA). Islamic Society of North America (ISNA), and the Muslim American Society (MAS), MedGlobal, Annual Gala Awards Dinner & **32nd** Arab-U.S. Policymakers Conference, and the American Muslim Medical Student Association, among others.
- Conducted over **170** educational and awarenessbuilding events, including Khutbas, public lectures, and informational presentations. Each engagement provided an opportunity to raise awareness, share stories of resilience, and mobilize collective action in support of those affected by the crisis.
- Brought our community together through 4 powerful events, blending celebration and purpose to honor Syria's journey toward freedom and raise vital support for its future.

HOW WE WORK

Needs Based

Our approach to programs is based on understanding and identifying the needs of local communities through various assessment tools, including interviews, focus group discussions, and surveys.

Strong Program Design

The Programs Department works to identify gaps and create a program aimed at addressing the root causes of needs.

Communities and local councils are consulted at this stage to better understand the feasibility of such programs and to ensure community participation.

Monitoring, Evaluation, Accountability, and Learning

Through this function, we can monitor the outputs of programs and measure their impact throughout baseline and end-line assessments.

It also provides access to beneficiaries to give their feedback and complaints.

Our MEAL department allows us to learn lessons from previous projects and apply them moving forward to strengthen our future programming.

Continuous Institutional Development and Capacity Building

Reviewing all the operations of the organization's departments and ensuring that the policies and procedures adopted are followed, in addition to developing suggestions and recommendations that enhance the internal control process and raise the level of professionalism and transparency within the organization.

We also make great efforts to build the capacities of the team, especially those working on the front lines.

- Distribute **400** fodder mill units to livestock breeders.
- Support over 5,800 farmers with agricultural training, tools, and safety and security equipment.
- Distribute **7.7K** meals during Ramadan, and **6,000** kg of meat portions for Eid al-Adha.
- Distribute over 13K food vouchers, 27.8K bread portions, and 1,800 readyto-eat kits.

Child Protection

- Establish 28 community committees and conduct 12 training courses on child protection against exploitation and sexual abuse.
- Distribute over **900** adolescent kits and **3,600** recreational kits.
- Provide more than 2,700 parental skills and over 12,400 awareness and psychosocial support sessions.

Women Empowerment

- Provide over 800 legal consultations for women and girls, and 37 training sessions on gender-based violence.
- Support over 2,600 gender-based violence cases through psychosocial activities and referrals to specialized sectors when needed.
- Provide over **750** vocational training sessions on sewing, handicraft, and entrepreneurship.
- Establish **13** community women's committees to identify and raise awareness on issues affecting women in the community.







General Protection

- Connect 1 water station to the electricity grid, establish
 2 water stations, 5 water networks, and 10 sanitation systems.
- Rehabilitate and install 5 concrete water tanks, and 440 drinking water tanks in camps and schools.
- Distribute over 76K hygiene kits, and more than 295K bars of soap, in addition to 79.4K jerrycans for water.

Education

Our education projects are designed to address the multifaceted challenges faced by children and teachers in northern Syria. Through our comprehensive efforts in schools' rehabilitation, distribution of educational materials, and targeted support for teachers, we seek to dismantle the barriers to education, fostering an environment where learning can flourish against all odds, because we believe that education is the most powerful tool for empowerment and change.

51,903 Beneficiaries

- Rehabilitate **44** schools and support **57** schools with operational expenses, furniture, and winter needs.
- Provide over **\$1.33M** as salaries to **2,251** teachers and administrative staff.
- Rehabilitate sanitization and sanitary facilities for **41** schools.
- Securing 56 field job opportunities through education projects.
- Distribute over **570** educational bags for teachers and conduct **90** Teacher Learning Circles and capacity-building training sessions to improve their skills.
- Distribute **11,900** textbooks, **15K** educational kits, and over **1,300** recreational tools, personal hygiene kits, and winterization kits for students.

Our Model Education

Our **Education Model** extends beyond curricula and technologies used; it requires a comprehensive focus on the **student**, the **family**, and the **teacher**. Providing an educational environment that encourages continuity in learning positively impacts students> development and helps them reach their full potential.

By involving both families and teachers, this **Education Model** enhances the educational experience and addresses the holistic needs of students.

In 2023, we opened our first two **Al Mountada Private Model schools** within the educational complex in Azaz. Building on that momentum, a new **Middle and High School** for boys opened its doors in **2024**.

We believe that education is not just a fundamental right for every child, but it is the cornerstone for achieving sustainable development and regaining agency in northern Syria.

It is the gateway that opens new horizons for individuals and communities, enabling them to achieve their aspirations and contribute to building a better future.







Our commitment extends beyond students—it also includes empowering those who guide them.

In **2024**, we began our **Teachers' Academy** capacitybuilding activities for educators, training **1,275** teachers to strengthen their skills and enhance the learning environment.

By engaging families in the educational process and equipping teachers with the tools to be both effective educators and strong advocates, we are bridging school and home life and creating a lasting impact across communities.


Economic Empowerment

Our economic empowerment projects reflect our commitment to achieving sustainable and comprehensive development in Syria. Our program aims to empower Syrians to achieve self-sufficiency through capacitybuilding training, small business grants, and advanced bootcamps to train Syrian youth on marketable skills in the technology sector, which enables them to attain sustainable job opportunities, contributing to optimal investment in individuals and enhancing the ability of local communities to recover and achieve sustainable stability.

SMALL BUSINESS GRANTS

\$1,000 - \$5,000 Value per Grant

Our projects are designed to empower the most vulnerable groups—women-led households, individuals with special needs, and those ready to work and generate income.

Guided by a tailored framework and strategic plan, we start by equipping participants with practical skills in small business management, activity planning, budgeting, market analysis, and profit forecasting.

This hands-on approach does more than provide knowledge; it builds confidence and opens pathways to independence.

By investing in people's potential, we're not only helping them support their families but also sparking local economic growth, strengthening community resilience, and reducing long-term reliance on external aid.

The grants supported projects such as:

- Women's beauty salon.
- Clothing shop.
- Grocery stores.
- Coffee roasters.
- Sewing workshop.

DOLLANI INITIATIVE

This initiative is part of the Syrian Forum's broader effort to economically empower youth in Syria through the rapidly growing field of digital technology.

It's designed to equip young people with in-demand digital skills—ranging from coding and design to e-commerce and digital marketing—enabling them to access remote work opportunities and build sustainable sources of income.

In a region where traditional job markets are limited and instability persists, **Dollani** opens new doors.

It not only enhances individual livelihoods but also contributes to the economic resilience of entire communities.

By tapping into the global digital economy, these youth are transforming their futures—turning skills into stability, and potential into progress.





Bootcamps

Intensive and specialized training courses in the digital technology sector to develop the skills of youth in Syria.

NO-CODE BOOTCAMP



Trainees learned how to master platforms to build functional web apps without programming.

The bootcamp focused on UI/UX design, workflow automation, and digital project development, equipping participants with job-ready skills for the digital economy.

DIGITAL MARKETING BOOTCAMP



Tailored specifically for women, this Digital Marketing Bootcamp offers a comprehensive blend of technical and vocational training, job readiness preparation, English language development, and psychological support.

It covers essential topics like social media marketing, SEO, content writing and design, and digital platform management. Beyond skills, it connects participants to real job opportunities.

ENTREPRENEURSHIP BOOTCAMP



This hybrid model blends a startup incubator with a hands-on training bootcamp, designed to empower aspiring entrepreneurs in northern Syria. Participants received intensive training in entrepreneurial skills and were guided by globally experienced mentors.

The program supported them in launching viable, investment-ready ventures, helping turn bold ideas into impactful, sustainable projects that create real opportunities and economic growth in their communities.



Projects Accepted and Supported:

- **Kayan:** A unique opportunity for local artists in northern Syria to shine through an online platform to sell their paintings internationally, connecting their talent with art lovers around the world. Complementing this digital reach, we also launched a physical exhibition at Azaz Mall.
- Maana: A free Wi-Fi network in northern Syria to make digital access more inclusive and seamless. With just one click, users can connect and access online content, making vital information more accessible and empowering communities through connectivity.
- English Bridge: The first English Language Learning Center in the region—a groundbreaking step in northern Syria. This center not only teaches children English but also connects them with peers from around the world, fostering cross-cultural exchange and global friendships.
- Syrian Saffron: A dedicated land was leased and fully prepared for Saffron cultivation, offering top-tier quality at the lowest production cost. The first crop has already been successfully harvested, and the project has now entered the bulb multiplication phase, ensuring long-term growth and sustainability.

Local Communities as Drivers of Social Stability

During the first quarter of **2024**, the Center completed its project launched in **2022**, implementing a series of local dialogues to support communities in the areas of economic recovery, governance, and reconciliation. The discussions addressed challenges related to trade in northern Syria, local reconciliation, governance, and safe housing, while proposing practical solutions from a community perspective.

Decentralization Project

The project aims to enhance understanding of local governance dynamics in Syria by examining the socioeconomic conditions across areas of differing influence.

It provides evidence-based analysis to support effective policymaking for governance and peacebuilding, through assessing governance realities, exploring reconciliation models, and analyzing challenges related to reconstruction, economic recovery, and community stability – ultimately strengthening local representation and sustainable development.

Tribe and Power in Syria: History and Revolution: A Study of Rural Composition and Map of Tribal and Clan Structures and Their Interactions in Aleppo and Idlib Post-2011

This book provides significant research space to examine Tribal and Clan Councils as an emergent organizational phenomenon within Syria's tribal sphere. It defines their nature, roles, and impacts on traditional tribal governance dimensions and analyzing how tribal structures fit within power equations and the contentious relationship with state management of factional loyalties. The book's chapters were built upon field interviews and focus groups encompassing over **780** sources from varied samples and social segments.

The Northern War: Syria's Drug Network, Jordan's Response, and Regional Options

This book examines drug trafficking in Syria as a complex security issue with regional dimensions. It analyzes the evolution of organized crime networks since **2011** and their impact on regional security. The work also explores Jordan's counter strategies combining security measures and diplomatic efforts—while focusing on Amman's available options to combat cross-border smuggling threats from Syria.

Our Impact

The Syria Sanctions Policy Program

In collaboration with the Observatory of Economic and Political Studies, intensified efforts to foster dialogue on sanctions, aiming to enhance their accountability role while mitigating their unintended consequences on civilians and NGOs.

As part of this initiative, we organized two high-level workshops in London with Madanya at Chatham House and Washington, D.C., with The Middle East Institute, bringing together key diplomatic actors and Syrian sanctions experts.

These discussions provided a platform to assess the evolving sanctions landscape, address challenges faced by humanitarian organizations, and explore policy recommendations for more effective and responsible sanctions implementation.





Advocacy Tours

GENEVA

- In addition to high-level diplomatic meetings, the Syrian Forum Delegation organized a side event during the Human Rights Council's 55th Session in March, 2024, titled "Navigating the Unknown: State **Responsibility and Global Efforts to Locate** Missing Syrian Migrants and Victims of Human Trafficking", the side event was sponsored by the Delegation of the European Union to the UN alongside other international organizations, brought together key stakeholders, including policymakers, human rights experts, and civil society representatives. This side event aimed to delve into the responsibilities of states and the collaborative efforts needed to tackle the crisis of missing Syrian migrants and human trafficking victims and focused on strengthening global mechanisms to locate missing Syrians, address the challenges of human trafficking, and reinforce state accountability.
- At the Human Rights Council's 56th Session, the Syrian Forum, alongside the Syrian Center for Media and Freedom of Expression, called on the Special Rapporteur on the Right to Education to address the educational challenges faced by Syrian internally displaced persons and refugees in neighboring countries. The intervention emphasized the critical role of education in early recovery, social stability, and peacebuilding in post-conflict societies.
- At the Human Rights Council's 57th session, the Syrian Forum Delegation organized a side event titled <u>"Referring</u> Syria to the ICC: Exploring Current <u>Options</u>" in collaboration with Legal Action Worldwide and sponsored by the Delegation of the European Union to the UN and other international organizations, and United Kingdom Mission to the UN.





NEW YORK

The Syrian Forum's advocacy team completed **3** successful tours in New York. In March, they engaged with **11** Member States, including a Global-South nation, to discuss Syria's Cross-Border Humanitarian Aid Mechanism.

In July, the team explored with several Member States the possibility of referring the Syrian situation to the International Criminal Court (ICC).

During the **79th UN General Assembly**, they met with **21** diplomatic missions to further discuss referring the Syrian case to the ICC. These discussions focused on legal precedents for forced displacement as a crime against humanity, aiming to establish accountability despite UN Security Council impasses. The ultimate goal was to mobilize Rome Statute signatory states to form a referral coalition.

WASHINGTON, D.C.

The Syrian Forum engaged in a series of key diplomatic and governmental meetings in Washington, D.C., intensifying efforts to call for stabilization funding, direct funding, a policy of localization, and the need for accountability in Syria.

The discussions were held with Congressional Representatives, Officials at USAID, the Department of State's Syria Desk, Bureau for Democracy, Human Rights, and Labor, and Global Criminal Justice.



Advancing Syria's ICC Referral: The Hague Advocacy Efforts

September

A series of advocacy meetings were conducted in The Hague to call for the referral of the situation in Syria to the International Criminal Court (ICC). Discussions focused on integrating the issue into international legal dialogues and increasing engagement from key stakeholders.

These efforts reinforced support for the initiative, with a particular focus on securing leadership for the referral process and continuing momentum gained in previous advocacy efforts.

December

A side event titled **"Redeeming the ICC Mandate: Possibility for Referring the Situation in Syria Under Article XIV"** was co-organized by the Syrian Forum, the Syrian Center for Media and Freedom of Expression (SCM), the Atlantic Council (AC), and Legal Action Worldwide (LAW) during the **23rd** session of the Assembly of States Parties to the Rome Statute of the International Criminal Court (ICC).

The event highlighted the critical role the ICC could play in addressing crimes committed in Syria, emphasizing the importance of referring to the Syrian situation under Article **14** of the Rome Statute.

In collaboration with Legal Action Worldwide and the European External Action Service Liaison Office to the International organizations, the Syrian Forum hosted a post-ASP-23 roundtable in The Hague titled **"Referring Syria to the ICC:** Exploring Current Options."

The event gathered key international stakeholders to advance leadership efforts for justice and accountability in Syria.

Discussions focused on mobilizing support for an ICC referral and strengthening momentum within diplomatic and legal circles.

Advancing Justice Through Advocacy

Through persistent advocacy, the Syrian Forum successfully contributed to the inclusion of justice-oriented language in **UN General Assembly Resolution A/3.C/79/L.45**, urging ICC member states to explore all avenues for referring the Syrian file to the Court.

The resolution, adopted by **85** countries, condemns ongoing human rights violations in Syria and stresses the need for accountability under international law.

This achievement resulted from a year of dedicated engagement, including high-level advocacy tours in The Hague, New York, and Geneva, side events, expert consultations, and legal studies.



Emphasizing Cooperation with Other Syrian NGOs to Advance Our Policy Priorities

- At the American Coalition for Syria's annual conference in Washington, D.C., the Syrian Forum delegation joined congressional meetings and a White House roundtable on Syrian policymaking. We also hosted a panel highlighting the Invest in Syria Initiative, reinforcing the Syrian Forum's leadership in driving economic empowerment efforts in Syria.
- As part of the Strategic Litigation Project, the Atlantic Council brought together key Syrian NGOs and victim associations to explore the creation of a "Syria Victims Fund" to support affected communities. Syrian Forum played a vital role in shaping the concept through preparatory and in-person workshops that outlined a potential framework for the fund.
- At the **79th UN General** Assembly, the Syrian

- Sponsored **30** television episodes of the program "Stories and Values," which was aired on Syria TV during the holy month of Ramadan.

- Organized a press conference in Damascus by the American Coalition for Syria and the British Syrian Council to discuss the upcoming phase in Syria's recovery and development.
